

- 4. The demand for payment of the subsequent installment of the grant should be placed with the ICMR in the prescribed proforms. The approved duration of the scheme is three years. The annual extension will be given only after review of the work done on the scheme during the previous year.
- Five copies of the annual progress report (as per Annexure 3 of format for annual progress report) should be submitted to the ICMR every year after completion of ten months of the project giving complete actual details of the research work done. Failure to submit the report in time may lead to termination of the project.

It may kindly be ensured that the JRF on the above mentioned project is appointed out of the ICMR-JRF qualified candidates only. A list of the same is available on ICMR website.
