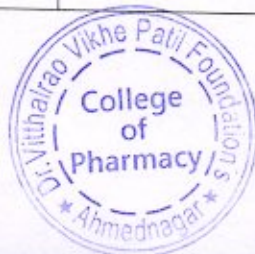


**Summary Report IQAC 2019-20**
