


## FUNCTIONS

Following grievances are redressed by Cell.


- The committee shall address grievances related to admissions.

### **Procedure for registering complaint:**

- An aggrieved student who has the Grievance shall make an application first to the Chairperson. Also, they are advised to contact their mentors or Class teachers personally to give their Grievances. Mentors/Class teachers communicate student grievances to grievance cell.
- The Grievance Redressal Cell will act upon those cases, which have been forwarded along with the necessary documents. Grievance committee shall study the petition and after looking in to the relevant documents, shall discuss the matter with those concerned.
- All the discussions will be minute and confidentiality is maintained.
- After verifying the facts, the Grievance committee shall try to redress the grievance within a reasonable time, preferably within a week of the receipt of application of the student.
- The Grievance Cell will assure that the grievance has been properly solved in a stipulated time limit provided by the cell.
- While dealing with the complaint, the committee at all levels will observed law of natural justice.

- The committee shall address their grievances regarding academic matters, financial matters, health services, library and other central services.



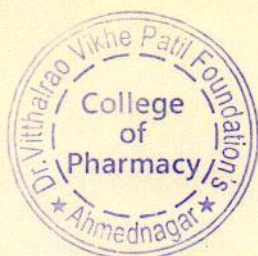

#### **Agenda 3: Information of Anti-ragging rules and regulation admission brochure.**

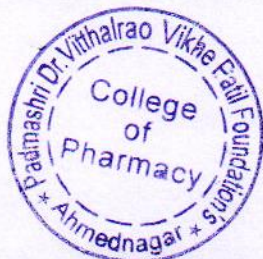

It was also ensured that every member should secretly carryout surprise raids in the college campus and sensible areas, so as to keep watch on the students activities to prevent ragging.







