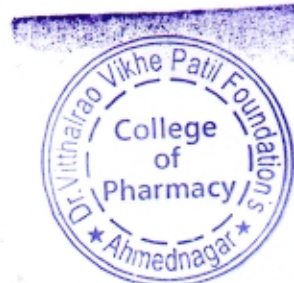
FUNCTION'S OF STUDENT COUNCIL IN COLLEGE
