Sir, as per Shikshan Sulka Samiti our fees for M.Pharmacy Course was Rs. 1,10,000/- for academic year 2013-14. 



Policy on concession to wards of employee—Financial year 2015-16

As regards concession to wards of employees, following policy is formulated-

1. No concession would be given to any student for the course of Medical College, Nursing College, Physiotherapy College, English Medium School & Jr.College.
2. For Technical Courses :-
 - a. For Mechanical & Civil Engineering Courses - 10% of Tuition Fess.
 - b. For other Courses in Engineering - 25% of Tuition Fees.
 - c. For all other Courses like Pharmacy, IBMRD (MBA & MCA), ITI & Agriculture - 25% of Tuition Fees.
3. For removal of any doubts, it is clarified specifically that the concession would be available ONLY for Tuition Fees.
4. In case the ward has claimed any scholarship, the concession would be on the Tuition Fee payable by the ward, if any, after adjusting the scholarship. For example, if the normal Tuition Fee is Rs. 50,000/- & the ward has claimed EBC scholarship of Rs. 25,000/-, then concession would be applicable only on the balance amount of Rs. 25,000/- of only Tuition Fees & not of Development Fees or any other fees.
5. The concession would be allowed only if the fees are paid in time. If installments are given, those should not exceed beyond the first semester.
6. This policy would be applicable only for Financial Year 2015-16. And it would be applicable to all the students - 1st year to final year - studying during the year 2015-16.
